### Plan Descriptions

A description of how parents, teachers, and school staff were involved in the development of the plan.

Ballington Academy – San Bernardino used various strategies to gain and foster engagement in the development of the plan. Most notably, to illicit input from parents, written surveys were frequently disseminated throughout the year as well as informal feedback via meetings both face to face and via an electronic platform. In addition, staff were involved in the development of the plan via feedback and input via both surveys and meetings. Feedback was also obtained from the Special Education team via meetings, review of benchmark data, and recommendations for teacher professional development. The resonating theme throughout all stakeholder groups noted the importance of the implementation of strategies to mitigate the possibility of learning loss and the importance of individualizing the strategies and interventions to meet the specific learning needs of students. Based on this several recommendations included extending the year to provide specific focus on academic areas of need and additional support from interventionalists trained specifically in areas of needed support from the support which is identified using objective assessment data.

Ballington Academy San Bernardino will utilize the NWEA MAP system, the primary benchmark assessment system currently used at Ballington San Bernardino to identify the needs of students. In addition to the NWEA MAP system, Ballington San Bernardino will use STAR reading as well as other benchmark assessments. This system will provide both diagnostic and formative data to be used to individualize academic support needs.

A description of how parents and guardians of students will be informed of the opportunities for supplemental instruction and support.

Ballington San Bernardino will use a plethora of systems to notify parents, guardians, and students for the opportunities for instruction and support. These systems include email, written memo, Class Dojo, Google Education, phone, newsletters, personal invitations, website, and text messaging. Communications will be in multiple languages as determined by stakeholders' needs.

A description of the LEA's plan to provide supplemental instruction and support.

The following strategies are being implemented:

- 1) Extending instructional learning time: Ballington Academy will offer an extended school year by providing an addition 6 weeks of academic instruction after the school year concludes. Instruction will be offered by a credentialed teacher in small groups 4 hours per day for five (5) days per week.
- 2) Accelerating progress to close learning gaps through the implementation, expansion, or enhancement of learning supports including but not limited to any of the following:
  - a. Tutoring or other one on one small group learning supports provided by a certificated or classified staff
  - b. Learning recovery programs and materials designed to accelerate student academic proficiency or English proficiency or both.
  - c. Educator training for certificated staff in accelerating learning strategies, student engagement, and assessment and data analysis to support student learning.

Ballington proposes to add two credentialed interventions who have expertise in Math and ELA development to provide intentional focused academic support via push in or pull out. Both interventionist will be present for the school day, M-F, and one will be available for afterschool for tutoring.

# Expanded Learning Opportunities Grant Plan Instructions: Introduction

The Expanded Learning Opportunities Grant Plan must be completed by school districts, county offices of education, or charter schools, collectively referred to as Local Educational Agencies (LEAs), that receive Expanded Learning Opportunities (ELO) Grant funds under California *Education Code (EC)* Section 43521(b). The plan must be adopted by the local governing board or body of the LEA at a public meeting on or before June 1, 2021, and must be submitted to the county office of education, the California Department of Education, or the chartering authority within five days of adoption, as applicable. The plan must be updated to include the actual expenditures by December 1, 2022.

## Instructions: Plan Requirements

An LEA receiving ELO Grant funds under *EC* Section 43521(b) is required to implement a learning recovery program that, at a minimum, provides supplemental instruction, support for social and emotional well-being, and, to the maximum extent permissible under the guidelines of the United States Department of Agriculture, meals and snacks to, at a minimum, students who are included in one or more of the following groups:

- low-income,
- English learners,
- foster youth,
- homeless students,
- students with disabilities,
- students at risk of abuse, neglect, or exploitation,
- disengaged students, and
- students who are below grade level, including, but not limited to, those who did not enroll in kindergarten in the 2020–21 school year, credit-deficient students, high school students at risk of not graduating, and other students identified by certificated staff.

For purposes of this requirement

- “Supplemental instruction” means the instructional programs provided in addition to and complementary to the LEAs regular instructional programs, including services provided in accordance with an individualized education program (IEP).
- “Support” means interventions provided as a supplement to those regularly provided by the LEA, including services provided in accordance with an IEP, that are designed to meet students’ needs for behavioral, social, emotional, and other integrated student supports, in order to enable students to engage in, and benefit from, the supplemental instruction being provided.

- “Students at risk of abuse, neglect, or exploitation” means students who are identified as being at risk of abuse, neglect, or exploitation in a written referral from a legal, medical, or social service agency, or emergency shelter.

*EC* Section 43522(b) identifies the seven supplemental instruction and support strategies listed below as the strategies that may be supported with ELO Grant funds and requires the LEA to use the funding only for any of these purposes. LEAs are not required to implement each supplemental instruction and support strategy; rather LEAs are to work collaboratively with their community partners to identify the supplemental instruction and support strategies that will be implemented. LEAs are encouraged to engage, plan, and collaborate on program operation with community partners and expanded learning programs, and to leverage existing behavioral health partnerships and Medi-Cal billing options in the design and implementation of the supplemental instruction and support strategies being provided (*EC* Section 43522[h]).

The seven supplemental instruction and support strategies are:

1. Extending instructional learning time in addition to what is required for the school year by increasing the number of instructional days or minutes provided during the school year, providing summer school or intersessional instructional programs, or taking any other action that increases the amount of instructional time or services provided to students based on their learning needs.
2. Accelerating progress to close learning gaps through the implementation, expansion, or enhancement of learning supports including, but not limited to, any of the following:
  - a. Tutoring or other one-on-one or small group learning supports provided by certificated or classified staff.
  - b. Learning recovery programs and materials designed to accelerate student academic proficiency or English language proficiency, or both.
  - c. Educator training, for both certificated and classified staff, in accelerated learning strategies and effectively addressing learning gaps, including training in facilitating quality and engaging learning opportunities for all students.
3. Integrated student supports to address other barriers to learning, such as the provision of health, counseling, or mental health services, access to school meal programs, before and after school programs, or programs to address student trauma and social-emotional learning, or referrals for support for family or student needs.
4. Community learning hubs that provide students with access to technology, high-speed internet, and other academic supports.
5. Supports for credit deficient students to complete graduation or grade promotion requirements and to increase or improve students’ college eligibility.
6. Additional academic services for students, such as diagnostic, progress monitoring, and benchmark assessments of student learning.
7. Training for school staff on strategies, including trauma-informed practices, to engage students and families in addressing students’ social-emotional health needs and academic needs.

As a reminder, *EC* Section 43522(g) requires that all services delivered to students with disabilities be delivered in accordance with an applicable IEP.

### **Fiscal Requirements**

The following fiscal requirements are requirements of the ELO grant, but they are not addressed in this plan. Adherence to these requirements will be monitored through the annual audit process.

- The LEA must use at least 85 percent (85%) of its apportionment for expenditures related to providing in-person services in any of the seven purposes described above.
- The LEA must use at least 10 percent (10%) of the funding that is received based on LCFF entitlement to hire paraprofessionals to provide supplemental instruction and support through the duration of this program, with a priority for full-time paraprofessionals. The supplemental instruction and support provided by the paraprofessionals must be prioritized for English learners and students with disabilities. Funds expended to hire paraprofessionals count towards the LEAs requirement to spend at least 85% of its apportionment to provide in-person services.
- An LEA may use up to 15 percent (15%) of its apportionment to increase or improve services for students participating in distance learning or to support activities intended to prepare the LEA for in-person instruction, before in-person instructional services are offered.
